RESOLUTION TO ADOPT THE ADJUSTED MAXIMUM MILLAGE RATES FOR GENERAL ALIMONY, DRAINAGE STREETS, STREETS & ALLEYS, RECREATIONAL FAC. & PUBLIC PARKS; AND LEVY THE BOND IN THE TOWN OF LAKE ARTHUR FOR TAX YEAR 2021.

SECTION 1: BE IT RESOLVED by the Mayor and Board of Aldermen of the Town of Lake Arthur, Louisiana, in regular and legal session convened, that the Town of Lake Arthur of the Parish of Jefferson Davis, Louisiana, in a public meeting held on August 4, 2021, which meeting was conducted in accordance with the Open Meetings Law, the following millage(s) are hereby levied on the 2021 tax roll on all property subject to taxation by the Town of Lake Arthur:

General Alimony (5173 001):	7.930 mills
Drainage System (5173 002):	5.450 mills
Streets & Alleys (5173 003):	5.450 mills
Recreational Fac & Public Parks (5173 007):	2.800 mills
Bond (5173 008):	4.000 mills

SECTION 2: BE IT FURTHER RESOLVED that the proper administrative officials of the Parish of Jefferson Davis State of Louisiana, be and they are hereby empowered, authorized, and directed to spread said taxes, as hereinabove set forth, upon the assessment roll of said Parish for the year 2021, and to make the collection of the taxes imposed for and on behalf of the taxing authority, according to law, and that the taxes herein levied shall become a permanent lien and privilege on all property subject to taxation as herein set forth, and collection thereof shall be enforceable in the manner provided by law.

The foregoing resolution was read in full; the roll was called on the adoption thereof, and the resolution was adopted by the following votes:




